### **Registration Fee:**

Each vendor is required to become a member of The Friendly Market. Annual membership fees are \$40.00. Registration fee is used to create your vendor profile on The Friendly Market website. Membership fees are due prior to set up on the first market day.

### **Market Space Agreement:**

Spaces are a minimum of 10'x12' with extra room behind the site. Due to the nature of the market layout, space shapes and sizes may vary. Vendor space fees are \$12/day without power hookup or \$15/day with power. Vendor spaces are limited. Spaces will be assigned on a first come first serve basis. Vendors must notify the market at least 48 hours before opening of the market of their intent to attend that day. Annual leases will be available and these vendors will receive a reserved spot at the market. The annual lease will allow vendors to leave their set up at the market at their own risk. If you leave any part of your set up you must attend the next market day. You may choose to purchase an annual lease for ½ price. The annual fee for a space is \$280.00, or \$365.00 for a space with power. This includes all market days from March 20th through October plus any additional dates.

### **Market Space Cancellation Policy:**

Any prepaid vendors will forfeit their space payment if the Market manager is not informed of a cancellation at least 48 hours prior to the market day. Upon notification,

the market manager will attempt to lease the space to another vendor. If the manager is successful in leasing the space to another vendor, then the market will refund a pro rated amount to the original vendor. Vendors are not permitted to sub lease their spaces. Vendors with an annual lease who fail to notify the market 3 or more times of their absence will forfeit their space and their lease fees. Vendors who reserve a space for an upcoming market and fail to show will be considered last for any future market dates.

**Participation Agreement:**

The vendor agrees to indemnify and hold harmless The Friendly Market and Minm at Enterprises Inc. from and against all liability, claims, demands, losses, damages, levies and causes of action or suits of any nature, arising out of or related to the applicants activities at The Friendly Market.
